RULES & REGULATIONS

1. Competition

- 1.1. my golf kaki Mar(ch)velous Golf Medal consisting of a single round of 18-holes, shall be played in **System 36** format in accordance with the rules of golf as approved by the R & A and USGA.
- 1.2. Men with handicap index shall tee off from white tees; and Ladies shall tee off from the red tees.
- 1.3. There is only ONE division (open division).
- 1.4. All competitors are requested to register at least 30 minutes before your starting times.
- 1.5. All competitors shall report and be stationed at their respective T-boxes at least 15 minutes before tee-off time.
- 1.6. Play shall commence according to the designated tee-time.
- 1.7. In the interest of all players in the tournament, please ensure that your flight is able to keep up with the preceding flight. The tournament committee reserves the right to make suggestions to players and their flights to speed up play.
- 1.8. Please repair all divots, repair pitch marks and rake bunkers.
- 1.9. Please observe all local rules (scorecard).

2. Handicapping

- 2.1. Handicaps for all competitors shall be determined by System 36, Strokeplay format.
- Handicap index for all competitors shall be current and recorded in the MGK Handicap Index Register as per 1st March 2013.

3. Conditions of Entry

- 3.1. All entries of my golf kaki Golf Medal must have official USGA Handicap Index (Handicapping). Inactive members are required to play at a lower Course Handicap than they would be entitled to if they were in the Active List.
- 3.2. Submission of entry is on a first-come-first-serve basis and confirmation of each entry is upon receipt of payment. The Organizing Committee reserves the right to limit, accept or reject entries and to allocate participants to different slots.
- 3.3. Once payment is received, there will be no refunds for withdrawal, cancellation or absenteeism.
- 3.4. Closing date for all entries is 19th March 2013. The Organizing Committee reserves the right to change the closing date at its own discretion, and to postpone or cancel the competition in the event that the targeted number of participants is not reached or should any other circumstances arise.

4. Score Card Return

- 4.1. All competitors shall submit GROSS score only.
- 4.2. Score cards must be completed with signatures of the marker and player and returned to the Score Card Return Counter immediately upon completion of the round.

5. Prizes

- 5.1. Participants are invited to attend a buffet dinner and prize presentation.
- 5.2. Trophy and Prizes will be awarded to the three participants with the best strokeplay points.
- 5.3. Participants who are present during dinner are eligible for lucky draw prizes.

6. Countback

6.1. In the event of ties, the USGA Countback System shall apply.

7. Inclement Weather

- 7.1. In the event of inclement weather resulting in the inability of the tournament to continue, the Organizing Committee shall decide on the standings of the tournament. The Organizing Committee's decision shall be final.
- 7.2. In the event that 50 percent of the competition field cannot complete, then the game shall be declared null and void.
- 7.3. No rain checks will be given even if the golfers have not teed off the second 9-holes of their game.

8. Disputes

- 8.1. Any complaints, protests or disputes shall be referred to the Organizing Committee for a decision and such decision shall be final.
- 8.2. The Organizing Committee shall reserve the right to amend the above Rules & Regulations.
