



## 1. Conditions of Booking

- 1.1. All golfers must have official USGA Handicap Index (Handicapping).
- 1.2. Submission of entry is on a first-come-first-serve basis and confirmation of each booking is upon receipt of payment. The Organizing Committee reserves the right to limit, accept or reject bookings and to allocate participants to different slots.
- 1.3. **Once payment is received, there will be strictly no refund.**
- 1.4. Replacement of golfer is not allowed once first round of golf has been played.
- 1.5. Both rounds of golf on the stipulated dates (24 & 31 July) are compulsory.
- 1.6. Play shall commence according to the designated tee-time at 8 minutes interval.
- 1.7. Closing date for all bookings is **Friday, 12 July 2019**. The Organizing Committee reserves the right to change the closing date at its own discretion, and to postpone or cancel in the event that the targeted number of participants is not reached or should any other circumstances arise.
- 1.8. Golfers are to abide by Marina Bay Golf Course's local rules and regulations.
- 1.9. Marina Bay Golf Course green fee voucher is not applicable for this event.
- 1.10. *my golf kaki* discount promotion is not applicable for this event.

## 2. Competition (4-Hole Match Play on Course B)

- 2.1. Golfer shall compete with his/her buggy mate. Single golfers will not be eligible to participate in the competition.
- 2.2. Match Play is only calculated based on 18 holes round of Course B only.
- 2.3. Only scores on holes 3, 6, 16 and 17 will be taken into consideration for the competition.
- 2.4. Men shall tee off from white tees, while Ladies and Juniors below 12 years old shall tee off from the red tees.

## 3. Handicapping

- 3.1. All golfers shall play off their official USGA Handicap Index as at 1 July 2019.
- 3.2. The maximum course handicap will be capped at 24 (for men) and 36 (for ladies & juniors below 12 years old).
- 3.3. Golfers with valid Proficiency Certificates or who have passed the Golf Course Swing Assessment will be assigned the maximum course handicap.

## 4. Scoring & Prizes

- 4.1. Each participant will only be eligible for one lucky dip prize.
- 4.2. All players shall only submit GROSS score using the designated score cards.
- 4.3. Score cards must be signed by both marker and golfer and returned to the Score Card Return Counter immediately upon completion of the round.
- 4.4. Prize will be given to the golfer who won the most number of designated holes.
- 4.5. In the event of a tie, the USGA Countback System shall apply based on the order of results for hole 16, 3, 17 and 6.
- 4.6. In the event of inclement weather resulting in the inability of the competition to continue, prize shall be given to the golfer with the most wins in the competition.
- 4.7. All prizes are to be redeemed at the Score Card Return Counter immediately upon final results.
- 4.8. Any complaints, protests or disputes shall be referred to the Organising Committee for a decision and such decision shall be final.

## 5. Inclement Weather

- 5.1. **Strictly no rain check is applicable for this event.**

## 6. Disputes

- 6.1. Any complaints, protests or disputes shall be referred to the Organizing Committee for a decision and such decision shall be final.
- 6.2. Under no circumstances is *my golf kaki* and NCI Golf Pte Ltd to be held liable for any injury or death howsoever or wheresoever caused to any visitors or golfers, or for any loss or damage howsoever or wheresoever caused to the to the belongings or properties of the visitors or golfers.
- 6.3. The Organizing Committee shall reserve the right to amend the above Rules & Regulations.
