1. Conditions of Booking

- 1.1. All golfers must have official USGA Handicap Index (Handicapping), otherwise the entry will be subject to review.
- 1.2. The Organizing Committee reserves the right to limit, accept or reject bookings, and for allocation of tee-time to participants.
- 1.3. Strictly for my golf kaki members only.
- 1.4. Once payment is received, there will be strictly no refund.
- 1.5. Closing date for all bookings is Monday, 11 April 2022. The Organizing Committee reserves the right to change the closing date at its own discretion, and to postpone or cancel the game if the targeted number of participants is not reached or should any other circumstances arise.
- 1.6. Golfers are to abide by Marina Bay Golf Course's local rules and regulations, and observe golf course safety, etiquette, and pace-of-play.
- 1.7. Any wrong declaration of citizenship status may be subject to disciplinary action and entry will be disqualified.
- 1.8. Promotional vouchers are not applicable for this event.
- 1.9. Only one winner per flight eligible for Mystery Hole mini-game. The Organizing Committee shall determine the winner in the event of a tie.

2. Balloting Terms

- 2.1. Each golfer may only submit their names once per event (one entry form = one ballot, for up to maximum of 4 names).
- 2.2. Multiple or duplicate entries are not allowed and will automatically be disqualified.
- 2.3. All booking forms should be fully completed and submitted by the stipulated deadline to be eligible for balloting.
- 2.4. Incorrect or incomplete forms will be deemed void.
- 2.5. Each application (Lead Golfer) will be assigned a reference number which will be used for the balloting.
- 2.6. Only successful golfers will be notified within one week after closing date.
- 2.7. Strictly no swapping of players after confirmation of slot.
- 2.8. Any misuse by golfers (eg. multiple swapping of players after successful ballot) may be subject to disciplinary action and have future entries denied.

3. Inclement Weather

3.1. Strictly no rain check is applicable for this event, even if golfer has not teed off.

4. Safe Management Measures

- 4.1. Golfers are to adhere to Marina Bay Golf Course's safe distancing measures and guidelines.
- 4.2. Only individuals with fully vaccinated status are eligible to participate and status will be checked before the game. Individuals found not fully vaccinated will be denied entry with no refund applicable.
- 4.3. Mask wearing is optional on-course. However, participants are encouraged to wear their masks for personal protection and to protect others.
- 4.4. All participants are to maintain safe distancing with no cross-mingling between each flight.
- 4.5. All participants are required to use TraceTogether Token/app for check-in and check-out.
- 4.6. There will be no shower, dinner, and lucky draw activities. All participants are urged to leave the premises immediately once the social golf is completed and after Mystery Hole mini-game winners have redeemed their gifts.

5. Disputes

- 5.1. Under no circumstances is *my golf kaki* and NCI Golf Pte Ltd to be held liable for any injury or death howsoever or wheresoever caused to any visitors or golfers, or for any loss or damage howsoever or wheresoever caused to the belongings or properties of the visitors or golfers.
- 5.2. The Organizing Committee shall reserve the right to amend the above Rules & Regulations.

6. Release Consent

- 6.1. By filling out this registration form, The Lead Golfer acknowledge that all personal data provided shall be disclosed and shared amongst the NTUC Club Group for the purposes set out in our Privacy Policy.
