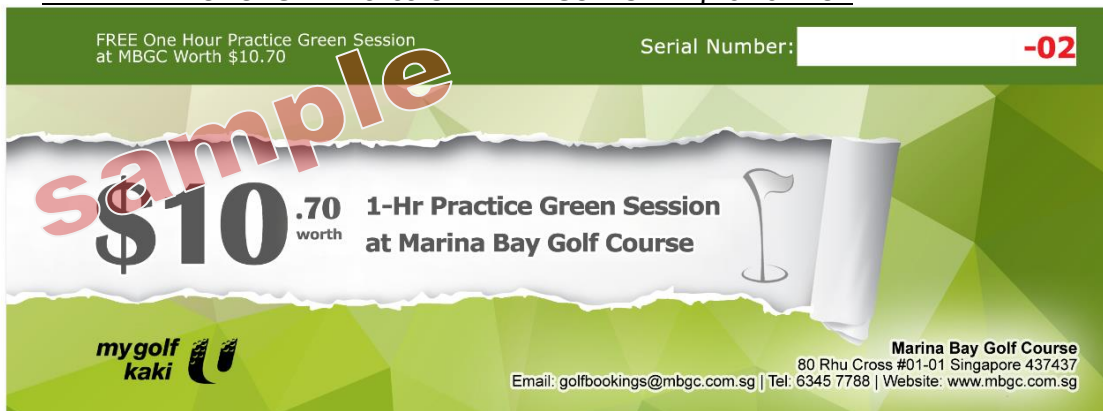


1 x MBGC DRIVING RANGE CARD WITH \$20 STORED VALUE
